**FOURTH ORDER OF BUSINESS**

**Financial Report for Period Ending May 31, 2017**

The Board reviewed the financials.

On MOTION by Mr. Church seconded by Mr. Stern with all in favor the financials were approved.

**FIFTH ORDER OF BUSINESS**

**Consideration of Change Order #21 with JW Cheatham, LLC for Plan Revision #5 for Persimmon Boulevard for an Increase of \$10,724.80**

Mr. Potts reviewed Change Order #21. Revisions had to be made for the existing utility at Persimmon Boulevard and conduits needed to be added for utilities.

On MOTION by Mr. Stern seconded by Mr. Church with all in favor Change Order #21 with JW Cheatham, LLC for an increase of \$10,724.80 was approved.

**SIXTH ORDER OF BUSINESS**

**Consideration of Change Order #22 with JW Cheatham, LLC for Water Main Connections at Persimmon, Pods H&K for an Increase of \$34,470**

Mr. Potts reviewed Change Order #22. Some utilities had to be revised in order to maintain the waterline active for the Grove Market and to provide water for the new lines. This was discovered during the process. The original design had rerouting of some water connections; however, they were unaware there were no shutoff valves at Grove Market. They had to come up with a workaround to keep them live while connected to the waterline.

On MOTION by Mr. Stern seconded by Mr. Church with all in favor Change Order #22 with JW Cheatham, LLC for an increase of \$34,470 was approved.

**SEVENTH ORDER OF BUSINESS**

**District Manager's Report**

Mr. Cassel reported they are still working with the City of Westlake to draft an Interlocal Agreement for infrastructure costs. The City of Westlake is also working with the County on an Interlocal Agreement for the traffic signalizations and maintenance.

Mr. Potts reviewed his monthly progress report; a copy of which is attached hereto and made a part of the public record. The Board requested the contractor provide a schedule of the work associated with the meter assembly. Mr. Potts also reported the lighting for Seminole Pratt Whitney Road will be submitted for review later this week.

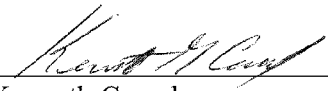
